## 2024 TEMPORARY GUARDIAN AND MEDICAL CONSENT FORM

This form is only required for children registering with Temporary Guardians.

**All Minors (under 18 years of age), Baptized or Unbaptized, must have a Parent or Temporary Guardian on site for the duration of the Camp.**

**Temporary Guardians must be baptized and at least 25 years of age. Pre-approval by the committee is required if you intend to be a Temporary Guardian for more than two children, not including the guardian's own children.**

For any minor that does not have a parent or legal guardian at the Camp, the parent or legal guardian must authorize another person (per below) to act as a Temporary Guardian for the duration of the 2024 Manitoulin Family Bible Camp which begins Saturday, July 13 and closes Saturday, July 20, 2024.

The parent or legal guardian must fill in and sign this form along with the designated Temporary Guardian. No minor child will be allowed to attend the Bible Camp unless they are with a parent or have a designated Temporary Guardian and are accompanied with a completed and signed consent form. Although the camp officially ends on Friday, July 19th, Temporary Guardianship must cover the period for packing up and leaving the camp.
